BOOKING & PAYMENT POLICIES

Caribbean Charter Flights (DBA) is a subsidiary of Caribbean Contract Services LLC (established at 2915 Ogletown Road – Newark, DE 19713 - USA) and Sun Destinations EURL (established at LD Deve – BP 541 - 97133 St Barthelemy – French West Indies).

All Charter Reservations must be prepaid by wire transfer to our US or EU Bank account within 48 hours of charter agreement issuance.

Additionally, all Charter Reservations must be guaranteed with a valid credit card provided by the client at reservation. The credit card is used as a form of guarantee and may be charged for initial deposit according to existing payment schedule (if any) and /or any additional charge incurred for the charter (such as airport taxes, VIP transfer or transit costs, reservation modification fees, facilities after hours fees, ground transportation fees, special catering fees, ..). Additional passenger fees may also be charged after the trip (such as for above normal craft interior cleaning or damage, unexpected harbor or airport fees, fees related to passenger special needs). Any credit card charge will appear on your card statement as payment to "PAYPAL *SUN DESTIN."

All Charter Reservations are not refundable.

Caribbean Charter Flights (and subsidiaries) will not be liable for airline schedule changes or cancellations, visitor/ immigration Visa issues, or others. We strongly recommend to subscribe to a travel insurance to cover unexpected situations.

Once charter is confirmed all changes up to 24 hours before departure are subject to \$550 USD (or EUR equivalent) modification fees (only one change permitted and within the same tourist season / year).

No show on scheduled time is considered as a charter cancellation with 100% penalty fee. However in case of late inbound arrival (such as an airline delay on the day of travel..) the operator may be able to reschedule the charter reservation (according to its availabilities and policies), with a last minute modification fee of up to \$300 USD (or EUR equivalent). Caribbean Charter Flights (and subsidiaries) is unable to offer any guarantee for that matter, which remains solely and entirely at the operator's discretion.

Airport Particularities

For all charter flights to and from St Barthelemy (St Barths – SBH, TFFJ): Charter operators (or Caribbean Charter Flights and subsidiaries) will not be liable for any delay and/or cancellation of the charter reservation due to traffic congestion, late inbound flight, or others, that may occur at the airport of transit. We remind you that the airport of St Barths is subject to sunrise and sunset landing restrictions (between September and January, Sunset time is at around 5:30 pm and between February and August, Sunset time is at around 6:15 pm. No take-off and landing are allowed outside daylight hours).

For all charter flights to and from St Maarten (SXM – TNCM): All passengers must keep the Boarding pass of their incoming flight as an "in-transit proof" to avoid the payment of the \$38 USD Airport Departure Fee.

Substitution Policy & Weather Disruptions

Caribbean Charter Flights (and subsidiaries) reserve the right to substitute an aircraft offering similar (or greater) value and transportation characteristics without prior notice nor financial compensation. In certain weather circumstances, pursuant to regulations and/or safety, the aircraft (or boat) will not be able to depart. Caribbean Charter Flights (and subsidiaries) in cooperation with the operator will review these issues affecting your travel and offer the best alternate solution to minimize travel disruptions.

Weights Limitations

The operator may ask for a list of the passenger and baggage weights in order to ensure compliance with regulations and weight limitations for aircraft performance. The final determination as to whether baggage will be accepted on your trip remains at the discretion of the charter operator in accordance with air (or sea) safety rules. Large, hard-sided or oversize items may not fit in some aircraft (particularly in helicopters). In addition, there are weight restrictions that may limit the charter operator's ability to accommodate large amount of luggage. In such situations, Caribbean Charter Flights (and subsidiaries) will not be liable for the transportation of such excess luggage and no financial compensation will be offered.
